The Brennity at Tradition, New Voting Precinct for Voters South of Tradition Parkway November 5, 2024 General Election

Gertrude Walker, Supervisor of Elections for St. Lucie County, announces a new precinct location for the upcoming General Election on November 5, 2024. The Brennity at Tradition is located at 10827 Stony Creek Way and will serve voters residing south of Tradition Parkway in Port St. Lucie.

Since the 2020 General Election, the voter population has grown at the Tradition Town Hall precinct from approximately 10,000 qualified voters to over 20,000. Due to lack of public facilities in the Tradition area, the Supervisor of Elections office must depend on the generosity of the community to permit the use of their facilities as precinct locations.

Gertrude Walker, Supervisor of Elections for St. Lucie County stated, "After several years of diligently searching for an additional site, we were successful in collaboration with the management team of the Brennity at Tradition to solidify a new precinct location. We are grateful to the Brennity at Tradition for their commitment to serve the community."

On September 3, 2024, the Board of County Commissioners approved Resolution No. 24-136 for the creation of a new precinct to accommodate the rapidly growing population in Tradition. With the addition of this new precinct, the St. Lucie County Supervisor of Elections aims to reduce the wait times on Election Day and improve the overall voting experience in the Tradition area. Voters in the Tradition area will be receiving notifications in the mail from the Supervisor of Elections office about changes to their assigned precinct location.

RESOLUTION NO. 2024-136

A RESOLUTION AMENDING RESOLUTION NO. 22-103 BY AMENDING THE BOUNDARIES OF ELECTION PRECINCT NO. 89 AND CREATING ELECTION PRECINCT 92; ESTABLISHING A REVISED PRECINCT MAP; ESTABLISHING BLOCK EQUIVALENCY DATA AND LEGAL DESCRIPTIONS FOR PRECINCTS NOS. 89 AND 92; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of St. Lucie County, Florida, has made the following determinations:

- 1. Section 101.001, Florida Statutes, authorizes the Board of County Commissioners, upon recommendation and approval of the St. Lucie County Supervisor of Elections, to alter or create voting precincts in the County.
- 2. Section 101.001 further provides that the Supervisors of Elections shall maintain a geographical information system map showing the current geographical boundaries of each precinct.
- 3. On June 7, 2022, the Board of County Commissioners adopted Resolution No. 22-103 establishing the boundaries of the St. Lucie County election precincts.
- 4. The Supervisor of Elections has recommended that the legal boundaries and polling places of certain precincts be amended and an additional precinct be added to better serve the voters of St. Lucie County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Lucie County, Florida:

SECTION 1. The boundaries of Election Precinct No. 89 are hereby altered. Beginning at the intersection of I-95 South Bound Lane and SW Crosstown Pkwy, proceed SW on I-95 South Bound Lane to the intersection of SW Gatlin Blvd and SW Tradition Pkwy. Then proceed west on the SW Tradition Pkwy to the intersection of SW Tradition Pkwy and the south entrance of SW Stony Creek Way. Follow SW Stony Creek Way to the intersection of the north entrance SW Stony Creek Way and SW Tradition Pkwy. Proceed west along SW Tradition Pkwy to its end and a line projected west to the Intersection of Range Line Road. Proceed north on Range Line Road to the intersection of Crosstown Pkwy. Proceed east on Crosstown Pkwy to the point of beginning. The voting place for said Election Precinct No. 89 shall be at the Tradition Town Hall, 10799 SW Civic Lane, Port St. Lucie, FL 34987.

SECTION 2. A new Election Precinct to be designated as Precinct No. 92 is hereby created from a portion of Election Precinct No. 89. Beginning at the intersection of SW Gatlin Blvd. and SW Tradition Pkwy., proceed west along Tradition Pkwy to the intersection of Tradition Pkwy and south entrance SW Stony Creek Way. Follow SW Stony Creek Way to the intersection of the north entrance SW Stony Creek Way and Tradition Pkwy. Proceed west along SW Tradition Pkwy to its end and line projected west to the Intersection of Range Line Road. Proceed south along Range Line Road to the intersection of Range Line Road and County Line Canal. Proceed east along County Line Canal to the intersection of County Line Canal and I-95. Proceed northbound on I-95 to the point of beginning. The voting place for said Election Precinct No. 92 shall be at The Brennity at Tradition Senior Living, 10685 SW Stony Creek Way, Port St. Luci, FL 34987

SECTION 3. A revised map of the precinct boundaries is attached hereto as Exhibit A and incorporated herein by reference.

SECTION 4. The assigned precinct to each census block for Precinct No. 89 and Precinct No. 92 shall be as set forth in Exhibit B, attached hereto and incorporated herein by reference.

SECTION 5. The revised legal description for Precinct No. 89 and the new legal description for Precinct No. 92 shall be as set forth in Exhibit C, attached hereto and incorporated herein by reference.

SECTION 6. Except as otherwise amended by this Resolution No. 24-136, Resolution No. 22-103 remains in full force and effect.

SECTION 7. This Resolution shall take effect on the date of adoption.


